

**Seattle Public Utilities/Cedar Grove/King County Solid Waste/Zeeks Pizza  
"COMPOSTIVAL SCRATCH CARD CONTEST"**

**OFFICIAL RULES**

**Important: Please read these rules before entering this contest (the "Contest").**

**By participating in the Contest, you agree to be bound by these Official Rules and represent that you satisfy all of the eligibility requirements set forth below.**

1. **Eligibility. CONTEST VOID WHERE PROHIBITED.** CONTEST OPEN ONLY TO RESIDENTS OF WASHINGTON STATE WHO ARE AT LEAST EIGHTEEN (18) YEARS OF AGE. IF YOU DO NOT MEET ANY OF THESE REQUIREMENTS, OR ANY OTHER ELIGIBILITY REQUIREMENTS IN THESE OFFICIAL RULES, THEN PROJECT PARTNERS ("SPONSOR") RESERVE THE RIGHT NOT TO AWARD PRIZES TO YOU. To be eligible to win a prize, entries must be completed and received by Sponsor in the format designated below. Directors, officers and employees of Cedar Grove, Seattle Public Utilities, King County Solid Waste, Zeeks Pizza, Colehour + Cohen and any of their respective affiliates, subsidiaries, agents, professional advisors, agencies, and immediate families of each are not eligible to win any prizes. All applicable federal, state and local laws and regulations apply. Limit one (1) prize per person.

3. **Disclaimer.** All project sponsors and any of their respective parent organizations, subsidiaries, affiliates, directors, officers, professional advisors, employees and agencies (together, the "Released Parties") will not be responsible for: (a) any late, lost, misrouted, garbled or distorted or damaged transmissions or entries; (b) telephone, electronic, hardware, software, network, Internet, or other computer- or communications-related malfunctions or failures; (c) any Contest disruptions, injuries, losses or damages caused by events beyond the control of Sponsor or by non-authorized human intervention; or (d) any printing or typographical errors in any materials associated with the Contest.

4. **Contest Period.** The Contest period ("Contest Period") starts at 12:01 AM (all times Pacific Time) on October 7, 2013 and ends at 11:59 PM on October 31, 2013 (the "Deadline"). All winning scratch cards must be received by the Deadline to be eligible to win a prize. Grand Prize tickets to the 11/3/13 Seattle Seahawks game will be null and void if redeemed after the Contest Period.

5. **Prizes.** Prizes will be awarded as follows: One (1) winner will receive two (2) tickets to the Seattle Seahawks game on 11/3/13, One (1) winner will receive a \$100 Zeeks Pizza gift certificate, 40 winners will receive a \$100 Zeeks Pizza gift certificate, 350 winners will receive a \$3 Discount on a Large Zeeks Pizza, 20 winners will receive two (2) Yards of Cedar Grove Compost Delivered within King County and 189 winners will receive one (1) Free Bag of Cedar Grove Compost. (Total approximate retail value of all prizes and discounts is \$6,995.) Any unredeemed prizes will remain the sole property of the Sponsor.

Odds of winning a prize depend on the number of eligible participants. **ALL FEDERAL, STATE AND LOCAL TAXES ASSOCIATED WITH THE RECEIPT OR USE ANY PRIZES ARE THE SOLE RESPONSIBILITY OF THE WINNERS. Prizes will only be awarded for those winning scratch tickets found and redeemed, consistent with these Official Rules, by the Deadline.** Prizes returned as undeliverable or otherwise not claimed within thirty (30) days after delivery of notification will be forfeited; excluding the Grand Prize tickets to the 11/3/13 Seattle Seahawks game which will be null and void if redeemed after the Contest Period Deadline. Prizes are not transferable. No substitutions or exchanges of any prizes will be permitted. Limit one (1) prize per entry.

6. **How to Enter.** Dine in or take-out from any Zeeks Pizza and get a scratch card for your chance to win great prizes.

7. **How to Participate; Determination of Winners.** Sponsor will distribute 601 winning scratch cards to King County Zeeks Pizza locations in Washington State. Participants must place an order (dine in or take-out) from Zeeks Pizza to receive a scratch card. In order to win, a participant must scratch the card to reveal a prize and follow the instructions on the card.

To redeem the Grand Prize of (2) tickets to the Seattle Seahawks game on 11/3/13 the participant must call 877-764-5748.

To redeem prizes from Zeeks Pizza, the participant must call 206-285-8646 to obtain a gift certificate; excluding the prize for \$3.00 off a Large Zeeks Pizza that can be presented at time of purchase.

To redeem the prizes from Cedar Grove prize for Two (2) yards of Cedar Grove Compost Delivered, the participant must call 877-764-5748. To redeem the prize for One (1) Free Bag of Cedar Grove Compost, the participant must go to cedar-grove.com/winner where they will be instructed to bring the card to one of their six (6) local landscape yards.

To claim a prize, each participant must follow the instructions on the scratch card by the Contest Period Deadline.

8. **General Release.** By entering the Contest, you release Sponsor and all Released Parties from any liability whatsoever, and waive any and all causes of action, related to any claims, costs, injuries, losses, or damages of any kind arising out of or in connection with the Contest or delivery, misdelivery, acceptance, possession, use of or inability to use any prize (including, without limitation, claims, costs, injuries, losses and damages related to personal injuries, death, damage to or destruction of property, rights of publicity or privacy, defamation or portrayal in a false light, whether intentional or unintentional), whether under a theory of contract, tort (including negligence), warranty or other theory.
